As the Mayor's South Boston neighborhood liaison for zoning and licensing matters, Sean oversaw those required public processes, and worked with developers, community and business leaders to ensure stakeholder participation and compliance, while representing the Mayor before each respective board.

A fifth generation Bostonian, Sean's personal ties to the city of Boston run deep, particularly in the community of South Boston. Growing up in Boston instilled a resilience and tenacity in Sean that he also brings to his representation of clients in his legal practice.

Sean graduated magna cum laude with his JD from New England School of Law Boston and his undergraduate degree from the University of Massachusetts Amherst.
